- 7 Vendor Space
- 8 Concessions for Athletes and Fans
- 9 Scoring Tables & Chairs
- 10 Sufficient Accessible Toilet Facilities
- 11 Public Announcement System
- 12 Host Hotel/Motel Within Walking Distance of Arena
- 13 Hotel/Motel Rooms for 1,000 per Night
